1. Police Pension contributions are calculated based on the Village's actuarial required contribution of 70.7% of annual payroll
2. Village Manager contract expires 4/30/2021. Contract adjustments unknown at time of posting, previous contract figures provided
3. Wages and IMRF employer contributions (if applicable) are estimated for these employees based on expected hours worked
4. In lieu of a regular pension, Chief D. Schar receives a set amount towards a deferred compensation retirement plan
5. Total compensation lower due to expected retirement in FY 2021-22
6. Represents Village contribution to Retirement Health Savings account, if elected
