The Certificate of Insurance shall provide that the insurance is not cancelable during the policy period without thirty (30) days written notice to the Village of Winfield, and the Village of Winfield shall be named as Certificate Holder. Worker's Compensation for any contractor or subcontractor who is a sole proprietor or partnership, and is not a corporation, need not have worker's compensation insurance on the owner or partners unless they so select.

All registration shall be valid until January 31st of the year following initial issuance. All annual renewal registrations are due by January 31st of that calendar year.
